

 M/s Awan Trading Company, Karachi being the 2nd lowest evaluated responsive "Successful bidder", for the supply of remaining quantity of 10,000 MT, against its quoted price of PKR 44,899 (inclusive of 18% GST) per Metric Ton totaling PKR 448,990,000/-
