SUPPLY OF 200,000 METRIC TONS SUB-BITUMINOUS COAL, WITH GIVEN COAL SPECIFICATIONS, FOR TESTING & COMMISSIONING OF 660 MW (GROSS) COAL-FIRED POWER PROJECT, JAMSHORO, SINDH, PAKISTAN

Jamshoro Power Company Limited (JPCL), a Government of Pakistan owned company, with its principal place of business at Jamshoro, Pakistan.

JPCL is setting up a 660 MW (Gross ISO) Supercritical Coal Fired Power Plant at Jamshoro Sindh, Islamic Republic of Pakistan. This Project is being financed by Asian Development Bank ("ADB"). The plant will use (i) 100% sub-bituminous coal when lignite is not available; OR (ii) Blended coal with 20% lignite and 80% sub-bituminous coal, as primary fuel and Natural Gas or High-Speed Diesel (HSD) as a secondary fuel.

JPCL intends to purchase 200,000 Metric Tons of sub-bituminous coal with such specifications as provided in the tender documents for testing and commissioning of the 660 mw (ISO-Gross) Coal Fired Power Project, Jamshoro.

Interested bidders may obtain the bidding documents, by paying the Tender Fee amounting to PKR 5,000/- in favor of Chief Executive Officer (GENCO-I), from 19.12.2022. Bids are invited on the basis of a "Single Stage – Two Envelope" procedure as per Rule 36(b) of the PPRA Rule, 2004.
