EXPRESSION OF INTEREST (EOI #-01/CFPP/2023) FOR SALE OF ASH AND GYPSUM 660 MW COAL FIRED POWER PLANT JAMSHORO

Jamshoro Power Company Limited (JPCL) is a Public Limited Company, having its Business Office at Mohra Jabal, Sehwan Road, Jamshoro Sindh, Pakistan. The JPCL is constructing a 660 MW Coal Fired Power Plant at Jamshoro (“*the Plant*”). The Plant shall operate on blended coal with 80% sub-bituminous coal & 20% lignite and on 100% sub-bituminous coal, when lignite is not available. The Plant is expected to commence its operation by first quarter of 2024 and to produce approx. 311 MT Fly Ash, 55 MT Bottom Ash and 100 MT Gypsum as byproducts daily and the Company intends to sell these products to potential Buyers.

In this regard, JPCL invites “Expression of Interest (EOI)” from interested parties for **(a) Sale of Ash (Fly & Bottom)** from Ash Silo and **(b) Gypsum** at CFPP, Jamshoro on “as-is and where-is basis”, for transportation, utilization and consumption to other locations in environment-friendly manner as per the guidelines of relevant Environmental Authorities/Agencies. The interested parties/firms having the all-relevant permits/licenses and NOCs should submit their Expression of Interest Applications to qualify for participation in subsequent “RFP Procedure”.
