2. ATL are eligible to participate in the bidding online.
3. The error free / without cutting encasing, shall upload on EPAD on due date as prescribed i.e 08-10-2025 upto 12.00 hrs
4. Original Registration with the Pakistan Engineering Council **(Civil)** Certificate.
5. Original Registration with Income Tax Department (NTN Certificates).
6. Original Registration certificate of Sindh Revenue Board, Government of Sindh is required
7. No tender without 05% Earnest money of the estimated cost of the BoQ for the tender will be considered. The bidder should deposite bid security as shown against the work in shape of **call deposit / Pay order** prepared from scheduled banks of Pakistan in favour of the RE(O) GENCO-I JPCL Jamshoro. The **call deposite / Pay order** should upload along with offered bid on E-Pad and the original **call deposite / Pay order** must be provide to tender opening committee before closing time of tender. The bid will not be considered without original **call deposite / Pay order**.
8. Improper / Incomplete or Conditional bids will be rejected straight away.
9. The procuring agency may reject all bids or proposal at any time prior to the acceptance of a bid or proposal. The procuring Agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds as per PPRA Rule-33 (1).

Hence the Bidder must Quoted the Bid which must covered the Min Wages of Labour of the said notification also covered the Applicable Taxes. Any Violation of aforementioned condition shall leads disqualification / Rejection of the Bid.
