Jamshoro Power Company Limited (JPCL), a fully Government of Pakistan (GOP) owned entity established under the laws of the Islamic Republic of Pakistan and a corporation incorporated under the Companies Ordinance 1984 with its registered office at WAPDA House, Shahrah-e-Quaid-e-Azam, Lahore, Pakistan and having its principal place of business at Jamshoro, Pakistan.

JPCL is setting up a 660 MW (Gross ISO) Supercritical Coal-Fired Power Plant at Jamshoro Sindh, the Islamic Republic of Pakistan "The Project "is being financed by Asian Development Bank ("ADB"). The plant will use (i) 100% sub-bituminous coal when lignite is not available or (ii) Blended coal with 20% lignite and 80% sub-bituminous coal, as a primary fuel and Natural Gas or High-Speed Diesel (HSD) as a secondary fuel.

JPCL intends to hire the Services of a Legal-Financial Consultancy Firm to perform different tasks related to Imported Coal Procurement, Power Purchase Agreement, Revision of PC-1, Tariffs, Implementation Agreement (IA), leading and assisting in discussions with CPPA (G) and NEPRA, Lenders, and other relevant forum and stakeholders with respect of 660 MW (Gross) Coal-Fired Power Project, Jamshoro.
