

Jamshoro Power Company Limited ("JPCL") is a subsidiary of GENCO Holding Company Limited ("GHCL"), a Government of Pakistan Entity. JPCL is developing a greenfield 2x660 MW (Gross) supercritical imported coal-fired power plant in Jamshoro, Sindh, Islamic Republic of Pakistan ("The Project") financed by Asian Development Bank ("ADB") and Islamic Development Bank ("IDB").

Coal Suppliers are invited to submit Statement of Qualification ("SOQ") to pre-qualify for International Competitive Bidding ("ICB") for supply of imported sub-bituminous coal under a Master Coal Supply Agreement, ("Master CSA"), with coal price, quantity, vessel to be finalized based on annual bidding process.
