Jamshoro Power Company Limited (JPCL) is a Public Limited Company (unlisted) working under the administrative control of the Ministry of Energy (MoE), Islamabad, having its Business Office at Mohra Jabal, Sehwan Road, Jamshoro Sindh, Pakistan. The JPCL is constructing a 660MW Coal Fired Power Plant at Jamshoro ("the Plant"). The Plant shall operate on blended coal with 20% lignite and 80% sub-bituminous coal and on 100% sub-bituminous coal when lignite is not available. The Limestone will be utilized for Flue Gas Desulfurization (FGD), the daily and annual consumption has been calculated & estimated at 85% Availability Factor as 150 and 50,000 Metric Tons, respectively. Limestone is a recurrent commodity whose market prices are fluctuating rapidly, the supply of which is required after every certain period of time, the JPCL intends to prequalify the prospective Suppliers/Contractors under an "Open Framework Agreement" for the period of three years, under PPRA Rules (as amended time to time).

JPCL invites sealed proposals from eligible Suppliers / Contractors for the "Supply of Limestone of required Quality & Quantity" as defined in the Prequalification Documents - "Schedule of Requirement".

The Contractors / Suppliers who are active taxpayers with sufficient relevant experience and meet the general eligibility/qualification criteria as stated in Prequalification Document should submit their proposals containing the Technical Profile of the Firm & List of previous supplies, etc. at the following address:
