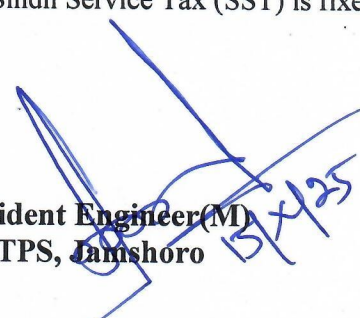

- 1) The Tender shall be uploaded on EPAD upto 20.10.2025 at 11:30 Hrs. Through EPAD.
- 2) The Tender shall be opened on same day at 12:00 Hrs. Through EPAD.
- 3) The work force will be allowed to engaged at the site after issuance of service order.
- 4) The labour will be worked under instruction of the concerned Engineer at site.
- 5) The payment will only be made by this office on submission of month wise bill after services providing by the said staff.
- 6) All safety measures is the responsibility of contractor to his labour engage at site during the work and ensure adopting all safety measures at work place. JPCL will not be responsible for any loss (injury or what so ever) due to incident occurs because of negligence of day contractor's worker at site.
- 7) Work force will be allowed to engage as following scope of work
  - Manpower : 01 No. Welder (Highly skilled)  
01 No. Electrical Technician  
\* 04 Nos. Helpers
  - Duty timings : 08 Hrs/day from 08:30 to 16:30 Hrs.
- 8) Eight (08) Hours per day, six (06) days a week, with one (01) unpaid weekly rest day.

- 10) OPD /Emergency facility shall be provided by the Contractor in case of any emergency during duty hours.
