### **PREAMBLE**

Jamshoro Power Company Limited (JPCL) is fully owned by the Government of Pakistan (GoP) and is incorporated under the Companies Ordinance 1984 with its principal place of business at Jamshoro.

Jamshoro Power Company Limited (JPCL) had initially awarded an EPC contract covering the design, procurement, construction, and commissioning of various facilities under the power project scope of construction of 660MW Coal Fired Power Plant at Jamshoro. Subsequently, JPCL has decided to withdraw the following EPC deliverables from the Contract:

- Manpower training in operation and maintenance
- Procurement and supply of locomotives
- Construction of an ash pond over approximately 100 acres of land, situated at a distance of 5 to 6 kilometers from the main power plant site.

Moreover, JPCL intends to procure "Critical and Capital Spares Parts" of newly constructed power plant through EPC contractor.

In this regard, JPCL intends to engage a third-party evaluator to independently assess and validate the cost implications associated with these withdrawn items or intended spare parts in coordination with the EPC Contractor.

### The Third-Party Evaluator will perform the following tasks

- ✓ **Review the EPC Contract** and relevant documents to understand the original scope and cost allocations.
- ✓ Coordinate with the EPC Contractor to obtain detailed cost breakdowns for the withdrawn items.
- ✓ **Assess the costs** associated with:
  - o Manpower training for O&M
  - o Procurement and supply of locomotives
  - o Construction of the ash pond (including civil works, land development, and related facilities)
  - o Procurement of intended Spare Parts
- ✓ Evaluate the reasonableness of the cost estimates, ensuring alignment with prevailing market rates, industry standards, and contractual benchmarks.
- ✓ **Prepare a comprehensive report** with itemized evaluations, methodology, findings, and recommendations.
- ✓ **Present the findings** to JPCL management and provide clarifications as required.

The Third-Party Evaluator will submit with JPCL the following deliverables:

- Detailed cost evaluation report
- Supporting documentation and working papers
- Summary of findings presentation (if required)

The assignment is expected to be completed within **30 calendar days** from the date of contract award/placement of Service Order and confidentiality shall be maintained strictly for all project data and findings.

The bidding shall be conducted in line with the "single stage-one envelope" (Technical and Financial Proposal in one envelope) procedure under Rule 36 (a) of the Public Procurement Rules, 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Public Procurement Regulatory Authority ("PPRA") from time to time and is open to all eligible consulting firms who come up with vast experience in consultancy services of similar assignments.
- 5. 2. Introduction	consultant from those listed in the Letter of Invitation, in accordance with the method of selection specified in the Data Sheet. The eligible Consultants are invited to submit a Technical
	Proposal and a Financial Proposal, or a Technical Proposal only, as specified in the Data Sheet, for consulting services required for the assignment named in the Data Sheet. The Proposal will be the basis for negotiating and ultimately signing the Contract with the selected
	Consultant.
	2.2 The Consultants should familiarize themselves with the local conditions and take them into account in preparing their Proposals, including attending a pre-proposal conference if one is specified in the Data Sheet. Attending any such pre-proposal conference is optional and is at the Consultants' expense.
	2.3 The Procuring Agency will timely provide, at no cost to the
	Consultants, the inputs, relevant project data, and reports required
	for the preparation of the Consultant's Proposal as specified in the
	Data Sheet.
3. Conflict of Interest	3.1 The Consultant is required to provide professional, objective, and impartial advice, at all times holding the Procuring Agency's interests paramount, strictly avoiding conflicts with other assignments or its own corporate interests and acting without any consideration for future work.
	3.2 The Consultant has an obligation to disclose to the Procuring Agency any situation of actual or potential conflict that impacts its capacity to serve the best interest of its Procuring Agency. Failure to disclose such situations may lead to the disqualification of the Consultant or the termination of its Contract and/or sanctions by the Authority.
	3.3 Without limitation on the generality of the foregoing, the Consultant shall not be hired under the circumstances set forth below:
a. Conflicting	(i) Conflict between consulting activities and procurement of
activities	goods, works or non-consulting services: a firm that has been



	engaged by the Procuring Agency to provide goods, works, or non-consulting services for a project, or any of its Affiliates, shall be disqualified from providing consulting services resulting from or directly related to those goods, works, or non-consulting services. Conversely, a firm hired to provide consulting services for the preparation or implementation of a project, or any of its Affiliates, shall be disqualified from subsequently providing goods or works or non-consulting services resulting from or directly related to the consulting services for such preparation or implementation.

To that end, the Procuring Agency shall indicate in the Data Sheet and make available to all eligible Consultants together with this RFP all information that would in that respect give such Consultant any unfair competitive advantage over competing Consultants.

a. Taxes	16.2The Consultant and its Sub-consultants and Experts are responsible for meeting all tax liabilities arising out of the Contract unless stated otherwise in the Data Sheet. Information on taxes in the Procuring Agency's country is provided in the Data Sheet.
b. Currency of Proposal	16.3The Consultant may express the price for its Services in the currency or currencies as stated in the Data Sheet. If indicated in the Data

- 17.3 Any modifications, revisions, interlineations, erasures, or overwriting shall be valid only if they are signed or initialed by the person signing the Proposal.
- 17.4 The signed Proposal shall be marked "ORIGINAL", and its copies marked "COPY" as appropriate. The number of copies is indicated in the **Data Sheet**. All copies shall be made from the signed original. If there are discrepancies between the original and the copies, the original shall prevail.

PST on Monday, 23 June 2025, the submission deadline indicated in the Data Sheet".
	17.6 If the envelopes and packages with the Proposal are not sealed and marked as required, the Procuring Agency will assume no responsibility for the misplacement, loss, or premature opening of the Proposal.
	17.7 The Proposal or its modifications must be sent to the address indicated in the <b>Data Sheet</b> and received by the Procuring Agency no later than the deadline indicated in the <b>Data Sheet</b> , or any extension to this deadline. Any Proposal or its modification received by the Procuring Agency after the deadline shall be declared late and rejected, and promptly returned unopened.
	17.8 A Consultant may withdraw its Proposal after it has been submitted, provided that written notice of the withdrawal of the Proposal, is received by the Procuring Agency prior to the deadline for submission of Proposal.

- 19.3 Second, outer envelopes marked "SUBSTITUTION" shall be opened. The inner envelopes containing the Substitution Proposal shall be exchanged for the corresponding Original Proposal being substituted, which is to be returned to the Consultant unopened. No envelope shall be substituted unless the corresponding Substitution Notice contains a valid authorization to request the substitution and is read out and recorded at bid opening.
- 19.4 Next, outer envelopes marked "MODIFICATION" shall be opened. No Technical Proposal and/or Financial Proposal shall be modified unless the corresponding Modification Notice contains a valid authorization to request the modification and is read out and recorded at the opening of the Proposal. Any Modification shall be read out along with the Original Proposal except in case of Single Stage Two Envelope Procedure where only the Technical Proposal, both Original as well as Modification, are to be opened, read out, and recorded at the opening. Financial Proposal, both Original and Modification, will remain unopened till the prescribed financial Proposal opening date.
- 19.5 The Procuring Agency's evaluation committee shall conduct the opening of the Technical Proposals in the presence of the Proposer Consultants' authorized representatives who choose to attend (in person, or online if this option is offered in the **Data Sheet**). The opening date, time and the address are stated in the **Data Sheet**. The envelopes with



	the Financial Proposal shall remain sealed until they are opened in accordance with Clause 23 of the ITC.

20.Proposals Evaluation	20.1 Subject to provision of Clause 15.1 of the ITC, the evaluators of the Technical Proposals shall have no access to the Financial Proposals until the technical evaluation is concluded.

	22.2 Only the Financial Proposal of the technically top-ranked Consultant (as predefined in the Evaluation Criteria) is opened by the Procuring Agency's evaluation committee. All other Financial Proposals are returned unopened after the Contract negotiations are successfully concluded and the Contract is signed.
23.Public Opening Financial Proposals (for QCBS, FBS, and LCS methods)	23.1 After the technical evaluation is completed, the Procuring Agency shall issue the Technical Evaluation Report containing all the information regarding responsiveness or non-responsiveness of the consultant along with the technical scores. The Financial Proposals of non-responsive consultants will be returned unopened after completing the selection process and Contract signing. The Procuring shall notify in writing those Consultants that have achieved the minimum overall



	technical score and inform them of the date, time and location for the opening of the Financial Proposals. Failure to confirm Key Experts' availability may result in the rejection of the Consultant's Proposal and the Procuring Agency proceeding to negotiate the Contract with the next-ranked Consultant.



# **Section VI: Terms of Reference**

### **Background:**

Jamshoro Power Generation Company-JPCL (hereinafter referred to as the **Client**) entered into an **Engineering, Procurement, and Construction (EPC) Contract** for construction of 660MW Coal Fired Power Plant Jamshoro. Certain components of the EPC scope of work have been **withdrawn and abandoned** by mutual consent of the Client and the EPC Contractor. These include:

- Training in Operational and Maintenance Personnel
- Procurement and Supply of Locomotives
- Construction of Ash Pond covering 100 acres of land, located at approximately 5~ 6 km distance from the project site

Moreover, the Client has requested the EPC contractor to add in the scope of EPC the procurement and supply of the critical and capital spare parts of the newly constructed power plant. The EPC has submitted a list of parts with cost which need to be evaluated and assessed for fair market price.

The EPC Contractor has submitted their claimed cost of the aforementioned withdrawn and additional works of supply. The Client intends to **engage an independent Third-Party Evaluator** to conduct an objective, transparent, and professional **cost evaluation** to determine the fair and reasonable value of these works for adjustment purposes.

The third-party evaluator firm/consultant to assess and review the cost of withdrawn and cancelled works (Manpower training, locomotives, and construction of 100-acre Slurry Ash Pond located 5~6 km away from main Power Plant) in an EPC contract document of 660MW Coal Fired Power Project, Jamshoro and additional cost of supply of parts.

- (d) any authority, corporation, body or organization established by or under a Federal Law or which is owned or controlled by the Federal Government:.
- (e) **Procuring Agency's Personnel"** refers to the staff, labor and other employees (if any) of the Procuring Agency engaged in fulfilling the Procuring Agency's obligations under the Contract; and any other personnel identified as Procuring Agency's Personnel, by a notice from the Procuring Agency to the Consultant.
- (f) "Consultant" means an individual consultant or a consulting firm as the case may be;
- (g) "Contract" means an agreement enforceable by law;
- (h) "Contractor" means a person, consultant, firm, company or an organization who undertake to supply goods, services or works.
- (i) "Contractor's Personnel" means personnel whom the Contractor utilizes in the execution of its contract, including the staff, labor and other employees of the Contractor and each subcontractor; and any other personnel assisting the Contractor in the execution of the contract to be supervised by the Consultant (if applicable).
- (j) "Day" means calendar day unless indicated otherwise.
- (k) "Effective Date" means the date on which this Contract comes into force and effect pursuant to Clause GCC 11.
- (l) "Experts" means, collectively, Key Experts, Non-Key Experts, or any other personnel of the Consultant, Sub-consultant or JV member(s) assigned by the Consultant to perform the Services or any part thereof under the Contract.
- (m) "Foreign Currency" means any currency other than the Pakistani Rupees.

- (n) "GCC" means these General Conditions of Contract.
- (o) "Government" means the Government of Pakistan.
- (p) "Joint Venture (JV)" means an association with or without a legal personality distinct from that of its members, of more than one entity where one member has the authority to conduct all businesses for and on behalf of any and all the members of the JV, and where the members of the JV are jointly and severally liable to the Procuring Agency for the performance of the Contract.
- (q) "Key Expert(s)" means an individual professional whose skills, qualifications, knowledge and experience are critical to the performance of the Services under the Contract and whose Curricula Vitae (CV) was taken into account in the technical evaluation of the Consultant's proposal.
- (r) "Local Currency" means the currency of Pakistan
- (s) "Non-Key Expert(s)" means an individual professional provided by the Consultant or its Sub-consultant to perform the Services or any part thereof under the Contract.
- (t) "Party" means the Procuring Agency or the Consultant, as the case may be, and "Parties" means both of them.

Other restrictions about the future use of these documents and software, if any, shall be specified in the SCC.

	33.2 In the event that any of Key Experts, Non-Key Experts or Sub- consultants is found by the Procuring Agency to be incompetent or incapable in discharging assigned duties, the Procuring Agency, specifying the grounds, therefore, may request the Consultant to provide a replacement.
	33.3 Any replacement of the removed Experts or Sub-consultants shall possess better qualifications and experience and shall be acceptable to the Procuring Agency.
34. Replacement/ Removal of Experts – Impact on Payments	34.1 Except as the Procuring Agency may otherwise agree, (i) the Consultant shall bear all additional travel and other costs arising out of or incidental to any removal and/or replacement, and (ii) the remuneration to be paid for any of the Experts provided as a replacement shall not exceed the remuneration which would have been payable to the Experts replaced or removed.

#### 35. Working Hours, Overtime, Leave, etc.

- 35.1 Working hours and holidays for Experts are set forth in **Appendix B**. To account for travel time to/from the Procuring Agency's country, experts carrying out Services inside the Procuring Agency's country shall be deemed to have commenced or finished work in respect of the Services such number of days before their arrival in, or after their departure from, the Procuring Agency's country as is specified in **Appendix B**.
- 35.2 The Experts shall not be entitled to be paid for overtime nor to take paid sick leave or vacation leave except as specified in **Appendix B**, and the Consultant's remuneration shall be deemed to cover these items.
- 35.3 Any taking of leave by Key Experts shall be subject to the prior approval by the Consultant who shall ensure that absence for leave purposes will not delay the progress and or impact adequate supervision of the Services.

### E. Obligations of the Procuring Agency

## 36. Assistance and Exemptions

- 36.1 Unless otherwise specified in the **SCC**, the Procuring Agency shall make its best efforts to:
- (a) Assist the Consultant with obtaining work permits and such other documents as shall be necessary to enable the Consultant to perform the Services.
- (b) Assist the Consultant with promptly obtaining, for the Experts and, if appropriate, their eligible dependents, all necessary entry and exit visas, residence permits, exchange permits, and any other documents required for their stay in the Procuring Agency's country while carrying out the Services under the Contract.
- (c) Facilitate prompt clearance through customs of any property required for the Services and of the personal effects of the Experts and their eligible dependents.
- (d) Issue to officials, agents and representatives of the Government all such instructions and information as may be necessary or appropriate for the prompt and effective implementation of the Services.
- (e) Assist the Consultant and the Experts and any Sub-consultants employed by the Consultant for the Services with obtaining exemption from any requirement to register or obtain any permit to practice their profession or to establish themselves

	either individually or as a corporate entity in the Procuring Agency's country according to the applicable law in the Procuring Agency's country.  (f) Assist the Consultant, any Sub-consultants and the Experts of either of them with obtaining the privilege, pursuant to the applicable law in the Procuring Agency's country, of bringing into the Procuring Agency's country reasonable amounts of foreign currency for the purposes of the Services or for the personal use of the Experts and of withdrawing any such amounts as may be earned therein by the Experts in the execution of the Services. 38. Change in the Applicable Law Related to Taxes and Duties	38.1 If, after the date of this Contract, there is any change in the applicable law in the Procuring Agency's country with respect to taxes and duties which increases or decreases the cost incurred by the Consultant in performing the Services, then the remuneration and reimbursable expenses otherwise payable to the Consultant under this Contract shall be increased or decreased accordingly by agreement between the Parties hereto, and corresponding adjustments shall be made to the ceiling amounts specified in Clause GCC 42.2.
39. Services, Facilities and Property of the Procuring Agency	39.1 The Procuring Agency shall make available to the Consultant and the Experts, for the purposes of the Services and free of any charge, the services, facilities and property described in the Terms of Reference ( <b>Appendix A</b> ) at the times and in the manner specified in said <b>Appendix A</b> .
