Scope of Bid	Supply of Complete Unit of "All Purpose Firefighting Vehicle" on Hino/Isuzu Chassis with Superstructure designed and built to combat various types of fires with allied accessories as per Schedule of Requirement and training of personnel on Operational Systems, to Jamshoro Power Company Limited (JPCL), a Government Owned Entity, under GENCO Holding Company Limited (GHCL), Ministry of Energy (Power Division) Islamabad.

Eligibility of Bidders	Bidding is open for all prospective and eligible firms who are ISO Certified and Active Tax Payers, specializing in Manufacturing and Developing Superstructures as per NFPA standards and Training of personnel on Operational Systems of Fire Firefighting Vehicles in Pakistan.

4.	Estimated Cost	As per prevailing Market Rate
5.	Bidding Procedure	The Bidding shall be conducted on "Single Stage - Two Envelope" Procedure as per PPRA Rule 36 (b). The Technical Proposal will be opened on the Bid Submission Date in presence of bidders' representatives who choose to attend. Only the Technically Qualified Bidders will be invited for Financial Proposal opening process. The evaluation will be carried out in accordance with "Least Cost Based Technique" to determine the Most Advantageous Bid and award of contract.
