- 1) The quotation shall be uploaded on EPAD upto 04.09.2025 at 11:30 Hrs. Through EPAD.
- 2) The quotation shall be opened on same day at 12:00 Hrs. Through EPAD.
- 3) The work force will be allowed to engaged at the site after issuance of service order.
- 4) The labour will be worked under instruction of the concerned Engineer at site.
- 5) The payment will only be made by this office on submission of month wise bill after services providing by the Technician.
- 6) All safety measures is the responsibility of contractor to his labour engage at site during the work and ensure adopting all safety measures at work place. JPCL will not be responsible for any loss (injury or what so ever) due to incident occurs because of negligence of day contractor's worker at site.
- 7) Work force will be allowed to engage as following scope of work
 - Manpower : 01 No. Skilled (Technician)
 - Duty timings : 08 Hrs/day from 08:30 to 16:30 Hrs.
- 8) 01 No. Technician supply contract shall be for the period of 156 Days.
- 9) Eight (08) Hours per day, six (06) days a week, with one (01) unpaid weekly rest day.
- 10) Over-time will not be applicable/admissible.

- 12) Transportation to and from the duty place will not be provided by the JPCL. The contractor will responsible for the transportation.
- 13) Casual and sick leave as per labour laws may be allowed during a work week on a pro-rotta basis.
- 14) Termination by either party by serving a notice of termination in a notice period of 15 days due to breach of contract, non-performance, misconduct or non-payment.
- 15) The disputes will be resolved amicably as per laws of Pakistan
- 16) Supplier shall be responsible for ensuring good conduct of workers and workers to follow clients safety, security and operational protocols
- 17) In case Government announces any public holiday or due to unavoidable circumstances, the quotation will be opened on next working days.
- 18) JPCL reserve the rights to reject all bids or proposals at any time prior to the acceptance of a bid/proposal as per Rule-33 of the PPRA
- 19) No quotation without 5% earnest money of quoted bid cost will be considered. The bidder should deposit bid security as shown against the work in the shape of **Call Deposit** pay order prepared from schedule banks of Pakistan must be attached with the bid as per PPRA Rule-25 in favour of RE(M) TPS, Jamshoro
