12. Validity



6. Sindh Stamp Duty



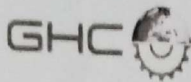
7. Sindh Sales Tax
