#### **Terms & Conditions:**

#### 1. "Cost Plus Fixed Fee (CPFF) Contract:

The cost involved in wages of manpower shall be fixed as per minimum wage laws and competition will be on the basis of variable cost of Management and Service Charges for arranging, managing and supervision of the manpower and overheads. No adjustments will be made during the contract period. The Service Order will be placed upon the firm offering the lowest rates.

#### 2. Scope of Service:

- Manpower: 03 unskilled persons
- Duty timings: 08 Hrs/day from 08:00 hrs to 16:00 hrs.
- o Duty location: Water Pretreatment Plant (WPT), 6.6 kV, 11kV Overhead Circuits.
- Responsibility: Watch and ward of Power Supply Lines of Old 6.6 kV Ckts and 11 kV New Ckts from WPT area to River Intake site, as per security & surveillance standards
- The services will be performed as per instructions from the Site Engineer.

#### 3. Period of manpower supply contract:

The manpower supply contract shall be for the period of three (03) months

#### 4. Working Hours and Days:

Eight (8) Hours per day, six (6) days a week, with one (1) unpaid weekly rest day.

5. Overtime:

Overtime will not be applicable/admissible.

6. Accommodation and food:

The JPCL will not be responsible for the provision of accommodation or food

#### 7. Medical Facility:

OPD/Emergency facility shall be provided by the Contractor in case of any emergency during duty hours.

#### 8. Transportation:

Transportation to and from the duty place will not be provided by the JPCL. The contractor will be responsible for the transportation.

9. Leave:

Casual and sick leave as per labour laws may be allowed during a work week on a pro-rota basis.

#### 10. Statutory Compliance:

The manpower supplier shall be responsible for compliance of social security and statutory liabilities such as compensation in cases of severe injuries or accidental death during performance of duty. Supplier to maintain a record for safety compliance.

#### 11. Service Standards:

The manpower supplier shall provide qualified manpower matching JPCL requirements, be physically fit, alert and active with good eyesight. Replacement for absentees, unfit, or underperforming workers will be made with the consent of the client.

#### 12. Liability & Safety:

The manpower shall be the liability of supplier for medical help, and compensation in cases of injuries or dead body repatriation.

The manpower shall be the employee of the supplier and JPCL takes no responsibility of any sort.

#### 13. Termination of contract:

Termination by either party by serving a notice of termination in a notice period of 15 days due to breach of contract, nonperformance, misconduct or non-payment.

#### 14. Dispute Resolution:

The disputes will be resolved amicably as per laws of Pakistan

#### 15. Discipline and Conduct:

Supplier shall be responsible for ensuring good conduct of workers and workers to follow client's safety, security and operational protocols.

16. The sealed quotations may be sent through courier or delivered in person up to 1200Hrs on 15-07-2025 and will be opened on the same day at 1230Hrs. in the presence of contractors who choose to be present at the office of Director Procurement PIU, 660MW CFPP Jamshoro.

The quotations may be deposited in the tender box kept for the purpose at the office of. Director Procurement, 2<sup>nd</sup> Floor Main Admin Building, Thermal Power Station, Jamshoro.

The quotations received late will not be accepted.

The quotations with overwriting/ cutting or doubtful figures will be rejected.

17. The manpower will be deployed immediately after receiving the service order but not later than 3 days.

## 18. Mandatory Tax requirement/Eligibility of Contractors:

The contractor/firm must be PEC registered and have registration with FBR and SRB and be on an active taxpayer list of FBR.

#### 19. Sindh Stamp Duty

0.35% of contract value shall be paid as stamp duty before issuance of service order

20. Sindh Sales Tax

Sindh Service Tax (SST) is fixed and will be charged at prevailing rates @15% of quotation value.

## 21. JPCL Facilities for night duty:

The Cotractor will provide torches and sticks /axe during night duty for clear vision and efficient surveillance

### 22. Billing and Payment Terms

All payments will be due on completion of month and will be paid on submission of the invoice duly verified by Site Engineer as per actual deployment of manpower and days earned through Cross Cheque, in favor of the Firm/contractor up to 10<sup>th</sup> day of each month.

#### 23. Force Majeure

Delays due to weather, natural calamities, strikes, or other unforeseen events beyond the control of the contractor will not be penalized.
