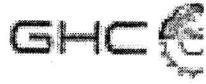


- The candidate will be initially appointed on contract basis for a period of **Two Years**, extendable on satisfactory performance.
